# About Us

The Sanctum Finance was founded in 2016 as an accounting and tax consulting company. In late 2017 the company opened a logistics division focused on road transportation of mining commodities.

The logistics division was taken off the ground through the onboarding of two well experienced parties who had also been long term associates of the founder of the company. To date the division has four employees excluding vehicle staff and continues to gain a steady foothold in the industry through the acquisition of long-term contracts with commodity producers, suppliers and buyers in Gauteng, Mpumalanga, Limpopo and the North West.

In early 2019 the company acquired 100% ownership in Essential Web (Pty) Ltd to gain entrance into the IT Development industry. The acquisition resulted in a boost in the subsidiary's operations through rigorous marketing and an integration of The Sanctum Finance's accounting and tax consultancy activities with the subsidiary's IT services.

The Group's integration of compliance, IT development and online marketing services has proven effective, with close to thirty upcoming business owners having been assisted with establishing their emerging brands while assisting these entrepreneurs with compliance to company regulations.

The Company opened a third division in construction in mid-2019. The division has acquired contracts with two parastatal entities to date which will commence in early 2020.

- Provision of load contracts to truck owners



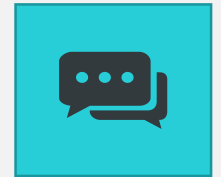
## CONSTRUCTION DIVISION

- The division will launch an EE/AA based learnership programme to intermediary university students from 2020 which will focus on skills development and job creation



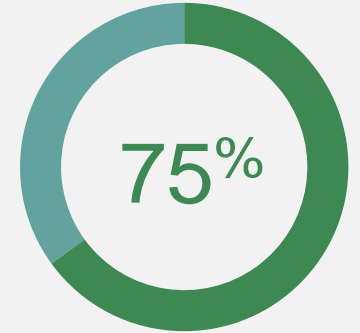
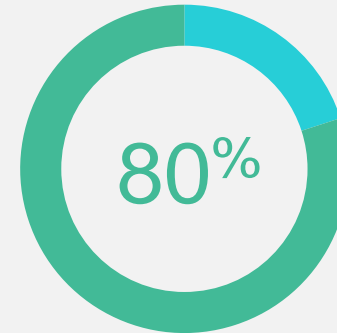
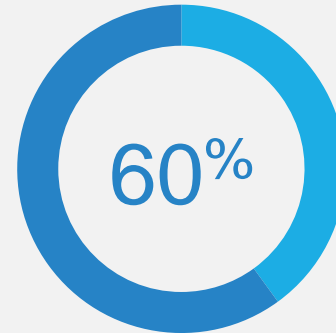
## TM Letsoalo

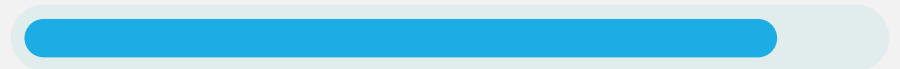

The group has four managers each charged with the fronting of its divisions. The management team has combined experience in logistics, accounting and tax, marketing and information technology.

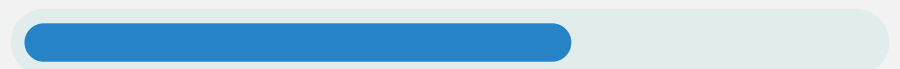
# Company Employee skill level



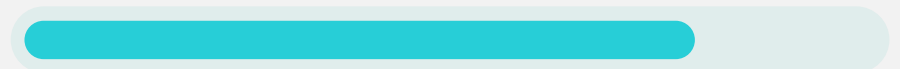

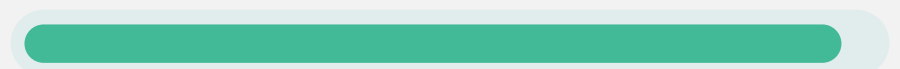

2019: Three-year transportation contract signed off with a coal supplier in Middleburg



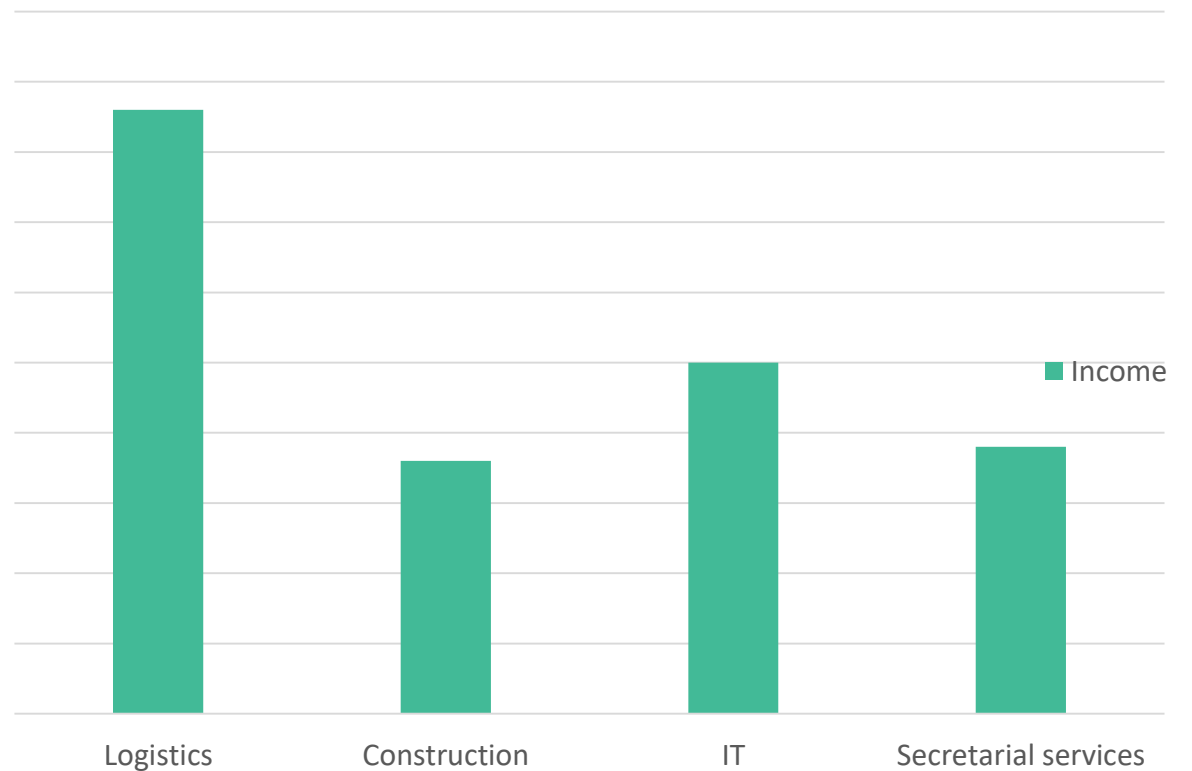
## We are visionaries
